### New Optum Rx cards do NOT affect benefits

Due to a system update, if you use Optum Rx for your prescriptions, you are receiving a new set of ID cards. This new card will not affect your 2019 pharmacy benefit in any way. The BIN, PCN, and RxGroup listed on your card have changed, and this will require some action from you, the member.

When you receive your new card, please do the following:

- Discard your old ID cards and begin carrying the new card enclosed with this letter.
- During your next trip to the pharmacy, bring your new ID card and present it at the pharmacy to fill your medications.
- If you use Mail order or a specialty pharmacy, please indicate your new card info on your next order.
- Login to the Optum Member Portal to re-register your online account. Once you re-register, any history will transfer and the online experience will be the same as it was in the past.

## Updates to your 2020 retirement system health care coverage

The Office of Retirement Services (ORS) works on your behalf to maintain a quality health care plan that's affordable and provides the services you need to live a longer, healthier life. The fall 2019 edition of *Best of Health* contains details about the changes to your retirement system health care coverage. The following are highlights of the updates that will be effective on January 1, 2020:
